Motion made by J Brown to pay the township bills of \$37,529.80 for General Fund; \$7,614.10 for Fire Fund and \$16,776.96 for Trash Fund, seconded by G Johnson. Motion Carried.

Motion made by M Brown to enact Policy 082018-2, PRE Interest Denial Distribution Policy, seconded by G Johnson. Motion carried all ayes.

Motion made by J Brown to allow Mike Nelson to establish Little Free Library at the park with cost up to \$600, seconded by M Brown. Motion Carried.

Motion made by T Wagar to appoint Robin Gage, Primary and Gary Johnson, secondary representative to the State Natural Rivers Program Board, seconded by M Brown. Motion carried.

Resolution offered by M Black and supported by M Brown In Opposition to HB6049 and SB 1025 concerning revamping assessing in entire state. Roll call vote: Ayes, G Johnson, M Black, M Brown, J Brown. Nay, T Wagar. Resolution adopted.
